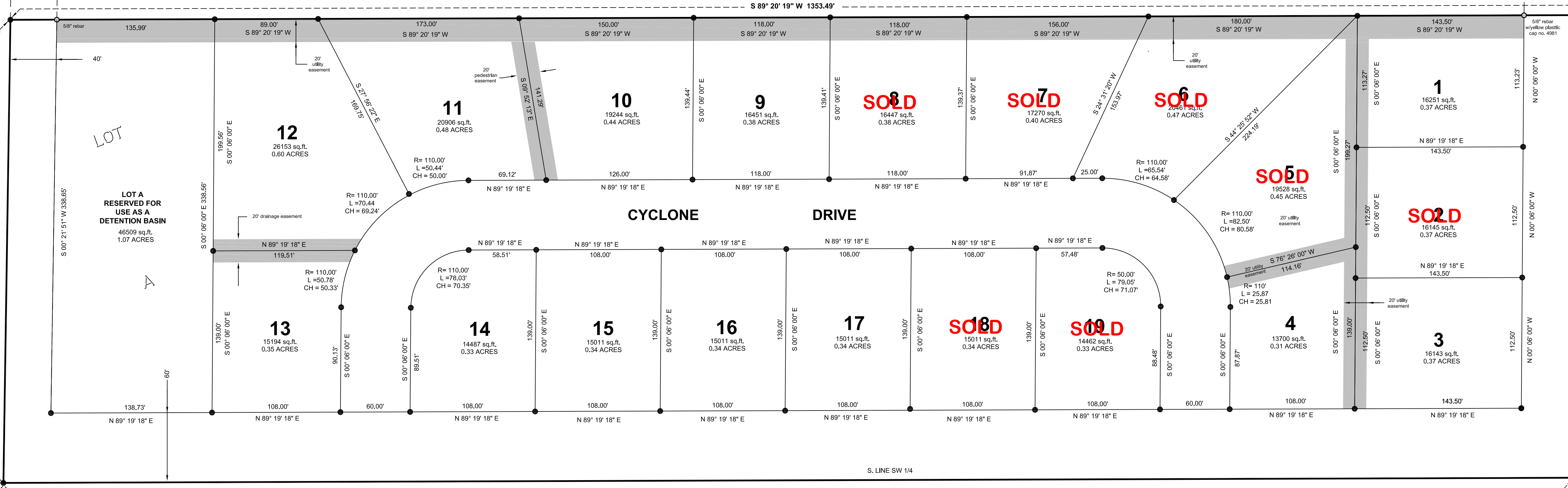

DESCRIPTION

A TRACT OF LAND LOCATED IN THE SOUTH HALF OF THE SOUTHWEST QUARTER (S 1/2 SW 1/4) OF SECTION 26, TOWNSHIP 91 NORTH, RANGE 38 WEST OF THE 5TH P.M., BUENA VISTA COUNTY, IOWA, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Beginning at the Southeast (SE) Corner of the Southwest Quarter (SW 1/4) of said Section 26; Thence on a previously recorded bearing of North 00° 06' 00" West, along the East line of said Southwest Quarter (SW 1/4), 398.22 feet to the South line of a tract owned by the Alta Community School District; Thence South 89° 20' 19" West, along said South line, 1353.49 feet to the centerline of the southerly extension of Main Street; Thence South 00° 21' 51" West, along said extended centerline, 398.67 feet to the South line of said Southwest Quarter (SW 1/4); Thence North 89° 19' 18" East, along said South line, 1356.72 feet to the Point of Beginning.

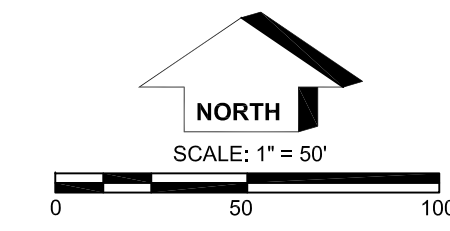

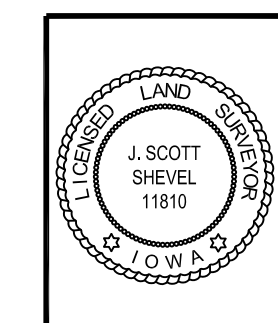
