A regular meeting of the Alta City Council was held on the above date in the Council Chambers of the Alta City Hall. The meeting was called to order at 6:02 PM by Mayor Ron Neulieb with the following members present: Pam Henderson, Jerry Buckendahl, Denny Weber, Vi Tilk, and Lee Meyer.

The agenda was approved on a motion by Weber, seconded by Tilk, with the following members voting aye: Henderson, Buckendahl, Weber, Tilk and Meyer. Motion approved.

The amended minutes from the March 6, 20, and 27 Council meetings were approved on a motion by Henderson, seconded by Meyer, with the following members voting aye: Henderson, Buckendahl, Weber, Tilk and Meyer. Motion approved.

Julie Fast, Chair of the Utility Board, spoke with the Council about the ownership and maintenance of the fire hydrants. Recently, 1 hydrant got damaged and the guilty party has not been located. The question became whose responsibility is it to maintain the hydrants: the Utilities (water) or the City (Fire department)? Currently, the City pays the utilities \$6356/year to help with the maintenance of the fire hydrants. Weber mentioned that he understood the hydrants belong to the water department. Fast asked if anyone knows how that number came about, and no one had an answer. She requested that the relationship be put into writing so in the future, everyone is clear on the ownership of the hydrants.

Fire Chief Reetz presented a written monthly report for the Fire Department. He said that by mid-June, the Department should have 6 more EMS providers. He also mentioned they are currently applying for a BV Community Foundation Grant to help with bunker gear. Minimal discussion took place regarding the 28E. Weber motioned to send the 28E to Skylar Limkemann for his professional approval, before we send it to our City Attorney, seconded by Meyer, with the following members voting aye: Henderson, Buckendahl, Weber, Tilk, and Meyer. Motion approved. No one was present for the Engineer's report, but the Council reminded the Citizens that there will be a workshop on April 5, at 4:00 PM, to learn more about the drainage issues. Travis Anderson and Alex Chavez presented the Sheriff's report. At this time, the Mayor proclaimed that the overnight parking ban has been lifted.

Andrea Hogrefe presented a calendar of events for April, and spoke about the events the library had going on in March. She said they had about 30 people attend the Laura Ingalls Wilder presentation. The week of April 10 is National Library Week. Randy Ericksen presented for the Park Board report. Baseball and softball are well underway. They continue to look for a few additional coaches. They are still looking at vending machines to have out at the pool. Henderson was given information from the school that a Trees For Kids grant was received and the school will be receiving 50-80 saplings to be planted around town. Pedersen presented the street department report. Boyd presented the Code Officer report. He has been working on getting a trailer, owned by the County, removed from the Trailer Park. The Industrial Board has placed their For Sale signs on their two lots on Main St. The Mayor spoke a bit about his month, and Henderson said the next trails meeting is set for April 18.

Council Member Henderson introduced the second reading of Ordinance #17-02 AMENDING THE 2015 ALTA ZONING ORDINANCE, BY AMENDING SECTION 11.5 FENCES, WALLS AND HEDGES and motioned for the third reading to be waived, seconded by Council Member Buckendahl. After due consideration, the roll was called and the following vote recorded: Ayes – Henderson, Buckendahl, Weber, Tilk and Meyer. Ordinance amendment #17-02 has been approved.

The Council spoke in length about the current stray dog ordinance. The taxpayers are incurring a cost when the street department gets called out on evenings and weekends to pick up stray dogs. The council gave Clerk Peterson some things to look into and they will continue working on this ordinance at the next meeting. After the previous regular meeting, the Council wanted to look over the current Alta Community Building contract, as well as the Aurelia Community Center contract. It was decided to continue taking reduced rent requests on a case by case basis.

Weber motioned to approve the 3-year proposal from T.P. Anderson & Co, for the City Audit, seconded by Tilk, with the following members voting aye: Henderson, Buckendahl, Weber, Tilk and Meyer. Proposal approved. Tilk motioned to approve the B.V. Fairgrounds and Raceway liquor license renewal, including outdoor service and Sunday sales, seconded

by Meyer, with the following members voting aye: Henderson, Buckendahl, Tilk, and Meyer. Weber chose to abstain due to conflict of interest since he is the Chair of the Fair Board. Motion approved. Weber motioned to approve the Century Bar liquor license renewal, including outdoor service and Sunday sales, seconded by Meyer, with the following members voting aye: Henderson, Buckendahl, Weber, Tilk, and Meyer. Motion approved. The council provided some suggestions to the semi-annual newsletter. Changes will be made and newsletter will be distributed by the H.S. boy's track team.
